FROM THE VICE PRESIDENT, Kenneth Fox:

On Tuesday, September 26, 2006 the Lake Murray Association will hold its third public meeting of the year. The meeting will be at Irmo Elementary School in Irmo, South Carolina. Our first featured speaker for this event will be Dr. Robert Seigler. Dr. Seigler is responsible for raising the B-25 Bomber from the bottom of Lake Murray where it had rested for over 60 years. Dr. Seigler has been selected as the Lake Murray Association Person of the Year.

Our next speaker will be Jim Griffin, Director of the Southern Museum of Flight, located in Birmingham, Alabama. The B-25 Bomber that was raised from the waters of Lake Murray is under the care of Jim and his museum staff.

Dr. A.W. "Bud" Badr will be our third speaker. Bud is the Chief Hydrologist with the South Carolina Department of Natural Resources. He will discuss the dynamics of our Lake Murray watershed and will explain some of the reasons why our lake level has not risen this year.

I encourage every member of the Lake Murray Association to attend this meeting because it will be very informative and interesting. I also ask each of you to inform your neighbors and friends who are not LMA members to join us for this very fascinating presentation.

DHEC RULES ON PARADISE COVE

DHEC has reached a proposed decision for the project described as Lighthouse Developments, Inc. community dock and boat ramp Lake Murray. We also know this as the multi-slip docks proposed for Paradise Cove.

DHEC has approved an 84 slip multi-use dock and concrete access ramp for the subdivision. No individual docks will be allowed along the 2000 feet of shoreline.

DHEC declared the waters in the cove were pH impaired; however, they feel the proposed project will not contribute to further impairment.

A wastewater pump out and disposal system for boats with marine sanitation devices (MSD's) is required at the facility. All patrons of this facility must be advised that the discharge from any MSD into Lake Murray is prohibited

A 25 ft. vegetative buffer along the shoreline will be required. The ownership of property goes to the 360' and it was decided it would not be feasible to require a 75' setback.

Approximately 135 concerned individuals contacted DHEC about the proposed development and received certified letters that the project has been approved and that they have 15 days to file a request for final review with DHEC.

After the DHEC process, compliance with FERC licensing requirements will be reviewed by the FERC. Those who wish to contact the FERC are encouraged to do so. LMA can provide the appropriate address if needed.

The DHEC notice stated that this type of facility is now banned currently by SCE&G and that this will be the final multi-use permit that may be issued on Lake Murray, unless the policy is changed.

Height Restrictions Approved

On August 22nd the Lexington County Council gave final approval on the maximum height for buildings along the shore of Lake Murray. The more than 300 miles of lake shore in Lexington County will be restricted to six stories or 70 feet to keep building height from dominating the tree line.

The B-25 and the Gold Watch

It's the stuff of which legends, lore and mystery are spun; history and heroes are made. It's also a love story. Last fall, the drama and a part of World War II came full circle when a B-25C Mitchell Bomber that ditched 63 years ago was retrieved from 150 feet beneath the surface of Lake Murray. While the aircraft is a treasure itself, so are the artifacts, including a gold watch, found in the cockpit.

The watch was a birthday gift and a token of a sweetheart's love for the co-pilot's birthday.

Lt. Bob Davison wasn't scheduled for a flight over Lake Murray the morning of April 4, 1943. Davison, a co-pilot in the Army Air Corps, filled in for a friend who couldn't fly that day. He was wearing a gold Bulova watch, an early birthday present from his fiancé, Ruth Brown. The watch was inscribed: "Ruth to Bob 3-5-43."

The B-25 took off from the Army Air Base outside Columbia on a skip-bombing mission over the lake's island targets, then ditched in the water about two miles west of Dreher Shoals Dam when the left engine lost power. The late Sewall Oliver hopped in his speedboat and rescued the five-man crew who had climbed onto a raft.

As Davison climbed out of the plane, the watch band caught on a broken window, and the watch went down with the plane. Ruth worked in a steel mill in Youngstown, Ohio and only made \$48 every two weeks. But she wanted to give something special to her fiancé for his birthday. She was making payments on the \$70 gold Bulova watch when it was lost. She was distressed because she had to continue making the payments to the jewelry store. It took her a year to pay off the watch.

The couple, who had been high school sweethearts in Youngstown, Ohio, married in June of that year. He was

21 and she, 19. Davison continued training in Colorado Springs and later, served in the Philippines. When he was discharged in 1945, the couple settled in Youngstown, Ohio. Eventually, they moved to Florida. When Davison died, Ruth moved back to Ohio. They have two children and six grandchildren.

Through the years, the missing watch became a family joke, she said. "We used to kid," she said. "I'd buy something and say, be 'careful.' "

Until last fall, the whereabouts of the missing watch remained a mystery. The watch, along with other artifacts, remained in the cockpit of the plane. For decades, Greenville pediatrician Dr. Bob Seigler had researched the plane. He and two partners, John Hodge and Bill Vartorella, formed the Lake Murray B-25 Rescue Project to find and retrieve the aircraft. Their team hoisted the aircraft last September. The watch and many other artifacts from the cockpit were well preserved.

The Southern Museum of Flight in Birmingham, AL is preserving the plane. The mystery of the watch was intriguing. It was solved last spring when Davison's brother, Vern, watched the History Channel's special on the B-25. Vern knew that his brother had been on that flight and that Ruth had given Bob a watch for his birthday.

The staff confirmed that Bob had been on the flight. "They were interested in the story of the watch," Vern said. "They were trying to trace the watch. I called Bob Seigler and he was interested too. "

Jim Griffin, director of the museum, said in an earlier interview that he had received hundreds of emails from around the world during the recovery process.

"It's not just a South Carolina event, but a worldwide event," he said. "The aircraft is a time capsule and a story of the crew who put it in the lake and went on to war afterwards."

Griffin said it's also a story of Seigler's fascination and many people working together to make it happen. "Our museum is delighted to have such an historically signature aircraft," he said. "It is a tremendous asset to our museum."

The museum will put the watch on display with the other artifacts in about a year, Griffin said. The nose of the aircraft already is on display.

"People have questioned me – didn't you want it (the watch) back?" Ruth said. "I thought if they (the museum) will display it, I'll leave it there." That way, she said, a lot of people can share it.

She hasn't seen the watch in 63 years, but hopes that she and her family can visit the museum to see the plane, the watch and other artifacts.

THE LMA WATER QUALITY MONITORING PROGRAM

During the past three months The Lake Murray Association has collected water samples from nine coves. Samples have been analyzed for fecal coliform and total phosphorus from all nine coves and for volatile organics associated with petroleum products in two coves where marinas are located.

In coves with marinas, volatile organics: Benzene, Toluene, Ethyl benzene and Xylene were below detectable levels on all sample collection dates and at all sample sites.

We have detected low levels of fecal coliform at many of the sampling sites during the past three months, but in no case have fecal coliform levels exceeded freshwater standards. On June 26, one sample site had a fecal coliform reading of 133/100 ml of water. This is the highest level we have found during the time we have been collecting samples and at this same site sampled July 27, fecal coliform dropped to 10/100 ml of water.

During the months of May and June there was very little rainfall, especially during the 7 days prior to sampling. Total phosphorus was below detectable levels at all sample sites on May 30 and below detectable levels at all sites except one when sampled June 26. The story changed dramatically for samples taken on July 27. About 1.5 inches of rainfall occurred during the 7 days prior to sampling. All sample sites, except one, exceed the freshwater standard of 0.06 mg/l for total phosphorus. In fact, coves LMA0101 and LMA0301 were above the standard by magnitudes of 8.83 and 7.83 respectively.

We collected samples on August 17, but do not have test results back yet. We collected chlorophyll-a samples from all sites which previously exceed the standard for total phosphorus. We want to determine if high phosphorus levels are contributing to elevated levels of chlorophyll-a, often associated with excessive algae growth.

Please see in the table below for total phosphorus test results for water samples collected May 30, June 26 and July 27.

Many Lake Murray Association members can not get their boats in the water. Our original plan was to have one person collect water samples from one cove near their residence. This has not been possible because of the low water. Special thanks go to Lake Murray Association members Ken Fox and Michael Murrell who have been collecting samples from several coves. Hopefully lake levels will return to normal soon!!!!

ENFORCEMENT OF BOATING SAFETY ON LAKE MURRAY

There is a committee of agency representatives, citizens and SCE&G personnel studying safety on Lake Murray as an integral part of the Saluda Hydro Relicensing process. The final products of the committee will be two reports; one will address the requirements of the Federal Energy Regulatory Commission (FERC) and the other will address a much wider range of safety issues. Of the various committees working on Relicensing, Safety is the only one planned at this time to continue its work into the future.

FERC regulations state that the licensee (SCE&G) is responsible for safety on the lake. (continued p5)

(continued from p4) However, FERC addresses with specificity only a relatively small number of issues such as signage, type size on signs, barriers, boat ramps, etc.

The majority of safety issues are addressed by SCE&G with the cooperation of a number of other organizations. By federal law, the **U. S. Coast Guard** has law enforcement authority on the Lake. Most of the USCG efforts are carried out by the U. S. Coast Guard Auxiliary unit housed on Flotilla Island on the lake; however, periodic patrols are assigned from the USCG command in Charleston.

Under South Carolina law, the primary enforcement responsibility is assigned to the **SC Department of Natural Resources** which provides periodic patrols on the Lake, is responsible for the placing and maintenance of shoal markers, provides diving and recovery resources in the case of drowning or missing persons, receives reports of boating accidents which are mandated by SC law, and offers several training classes.

The **sheriff's departments** of the four counties which border the lake provide some patrol services and respond to calls when their boat patrols are on duty. The only department which provides 24/7 service is the Lexington County Sheriff's Department (LCSD). Through an agreement among the sheriff's departments, a 911 call from any county or on the water is relayed to the LCSD Marine Division headquartered on Bundrick Island near Bomb Island and deputies have authority in each county. LCSD responds to calls in all of the four counties. In addition to law enforcement and search and rescue services, LCSD has specialized equipment to rescue injured persons on the water and fire fighting capability on several craft. These craft can draw water from the lake to supply fire equipment on land where there are no fire hydrants and they have water cannons which can apply water directly to a fire if it is located adjacent to the water. Most sick and injured are taken to the nearest appropriate land location where they can be transferred from the rescue boat to an ambulance. In addition, the Lake Murray Association (LMA) maintains wind socks at eight locations around the Lake at which helicopter ambulances may land and pick up patients from rescue boats. In either situation, patients are transported to local hospitals for treatment.

No Word on 9.3 Million Dollar Grant! By Joy Downs

LMA is still hoping for approval of a share of the 9.3 million dollar grant proposed by SC in April 2005.

Our request for \$27,485 to fund our water quality testing program was sponsored by Representatives Chip Huggins and Nathan Ballentine. We need at least \$25,000 next year for additional equipment and to conduct more tests than originally planned.

SCE&G continues to hold relicensing meetings quarterly for the general public. The last meeting was held July 18th at Saluda Shoals on Bush River Road. Two meetings were held that day at 10:00 AM and 7:00 PM.

Members of Kleinschmidt and Associates, hired by SCE&G to coordinate the relicense, gave power point presentations on the progress of the various Resource Conservation Groups.
